PURPOSE: If approved by the Navajo Nation Council, this legislation would approve the reopening of the Lake Powell Navajo Tribal Park, Monument Valley Navajo Tribal Park, Monument Valley Welcome Center, Little Colorado River Navajo Tribal Park, Four Corners Monument, Tséyi' Diné Heritage Area at the Orange Status notwithstanding Public Health Emergency Order 20-21-005. It would also support and approve implementation of the Division of Economic Development's Business Reopening Plans at Orange Status for businesses operating within the Lake Powell Navajo Tribal Park, Monument Valley Navajo Tribal Park, Monument Valley Welcome Center, Little Colorado River Navajo Tribal Park, Four Corners Monument, Tséyi' Diné Heritage Area notwithstanding Health Emergency Order 2021-005.

This written summary does not address recommended amendments as may be provided by the standing committees. The Office of Legislative Counsel requests each Council Delegate to review each proposed resolution in detail.

27	SECTION ONE. AUTHORITY
28	A. The Health, Education and Human Services committee is a standing committee of the
29	Navajo Nation Council. 2 N.N.C. §400(A). The committee provides "legislative
30	oversight on matters involving health," and oversees "Navajo Nation efforts in

- implementing and ensuring compliance with employment and labor laws and policies of the Navajo Nation." 2 N.N.C. § 400 (C)(1) and § 400 (C)(3). Also, the committee has authority to review and recommend "[r]esolutions relating to ... health, environmental health, ... employment and labor." 2 N.N.C. § 401(B)(6)(a).
- B. The Resources and Development Committee is a standing committee of the Navajo Nation Council. 2 N.N.C. § 500(A). The committee has oversight authority over matters such as water, land, economic and community development, commerce and trade. See, 2 N.N.C. § 500 (C). The committee also has oversight authority over the Division of Natural Resources, Parks and Recreation Department. 2 N.N.C. § 501(C)(1).
- C. The Naabik'íyáti' Committee is a standing committee of the Navajo Nation Council. 2 N.N.C. §700(A). The committee, among other responsibilities, has authority over proposed resolutions requiring "final action by the Navajo Nation Council." 2 N.N.C. § 164(A)(9).
- D. Pursuant to 2 N.N.C. §102(A), the Navajo Nation Council is the "governing body of the Navajo Nation."

SECTION TWO. FINDINGS

- A. "The Navajo Parks and Recreation Department is responsible for the management and operation of established tribal parks, monuments, recreation areas, the planning and development of visitor services, facilities and accommodations therein, and recommends the establishment of new parks." *See* RDCJY-031-19, Exhibit 1.
- B. The World Health Organization (WHO) declared a Public Health Emergency of International Concern related to the outbreak of coronavirus (COVID-19), a highly contagious and sometimes fatal respiratory virus on January 30, 2020; the U.S. Department of Health and Human Services declared a Public Health Emergency related to the COVID-19 outbreak on January 31, 2020; and the WHO declared a global pandemic due to COVID-19 on March 11, 2020.
- C. The Navajo Nation Commission on Emergency Management, with the concurrence of Navajo Nation President Jonathan Nez, declared a Public Health State of Emergency

- on the Navajo Nation on March 11, 2020 due to COVID-19. Resolution No. CEM 20-03-11. The Navajo Nation Department of Health subsequently issued numerous Public Health Emergency Orders to contain the spread of the COVID-19 virus.
- D. Public Health Emergency Order No. 2021-005, attached as **Exhibit A**, at page 1 paragraph III, states that "The Navajo Nation is experiencing a gradual downward trajectory of new cases, with a slowed infection rate and no sustained rebound."
- E. Public Health Emergency Order No. 2021-005, at page 2 paragraph B, states that "Per the Plan's 'reopening status schedule,' the Navajo Health Command and Operations Center ("NHCOC"), having evaluated the current state of the Navajo Nation per the gating criteria and public health considerations provided in the Plan, declares the Nation to be in Orange status. All businesses shall be bound to the conditions and requirements of Orange status. The NHCOC will announce any future status changes by Public Health Emergency Order."
- F. Public Health Emergency Order No. 2021-005, at page 3 paragraph C, states "Orange status is defined as: 25% of maximum occupancy allowed for most businesses. Restaurants and Dining facilities: drive-thru and curb-side permissible. Restaurants with permanent outdoor dining may provide outdoor dining at 25% of maximum capacity, as long as social distancing between tables is enforced; Restaurants without permanent outdoor dining are allowed up to 10 outdoor tables (max 4 persons per table), as long as social distancing between tables is enforced. Personal Care and Services: service by appointment only and allow time for cleaning between appointments. Marinas and parks: appointment only. Casinos and video poker: Navajo casinos are allowed to open to Navajo Nation residents and employees only. Not Allowed in Orange Phase: youth programs, museums, flea markets, roadside markets, gyms, recreation facilities, movie theaters."
- G. The opening of the Navajo Nation at Orange status through Public Health Emergency Order does not apply to all businesses. On page 1 paragraph VI, the Order states that "Tribal parks will not be accessible to Visitors and Tourists during this time." In addition on page 2 paragraph C states "Marinas and parks: appointment only."
- H. Nation parks including Lake Powell Navajo Tribal Park, Monument Valley Navajo

Tribal Park, Monument Valley Welcome Center, Little Colorado River Navajo Tribal Park, Four Corners Monument, Tséyi' Diné Heritage Area are not included in the Orange status 25% of maximum occupancy as defined in Public Health Emergency Order No. 2021-005 and otherwise may open by "appointment only."

- I. Navajo Nation residents who derive their income from selling their arts and crafts and services at the Lake Powell Navajo Tribal Park, Monument Valley Navajo Tribal Park, Monument Valley Welcome Center, Little Colorado River Navajo Tribal Park, Four Corners Monument, Tséyi' Diné Heritage Area have felt the adverse economic effects of the closure of these Navajo Nation parks. Given that the "Navajo Nation is experiencing a gradual downward trajectory of new cases, with a slowed infection rate and no sustained rebound," these vendors should be allowed to resume their livelihood generated from sales at the Navajo parks.
- J. Public Health Emergency Order 2021-05 states: "All businesses will be required to submit a COVID-19 Reopening Plan to the Navajo Nation Division of Economic Development before reopening in Orange Status. Reopening plans can be emailed to: navajoeconomy@navajo-nsn.gov"
- K. The Navajo Nation Reopening website <navajoreopening.navajo-nsn.gov> states that such policies and procedures must:
 - 1. Ensure physical distance between personnel, customers, and any member of the public at the place of business is maximized, and that keeping six-feet between persons is possible at all times.
 - 2. Address requests of personnel who are members of a vulnerable population for special accommodations.
 - 3. Provide that the entity or organization will carry sufficient and appropriate PPE based on industry best practices.
 - 4. Provide that the entity or organization will carry sufficient disinfectant products.
 - 5. Require hygiene practices such as cleaning frequently-touched surfaces and handwashing.

- 6. Provide for conducting regular employee COVID-19 screenings, such as temperature checks, checklist or diagnostic testing.
- 7. Provide for on-going safety training and education on COVID-19.
- 8. Provide standards for how to respond to suspected and confirmed cases of COVID-19 among employees. The policies and procedures shall further provide contact information for the nearest healthcare facility, and such information posted conspicuously at the place of business (e.g., informational poster). The place of business shall contact the healthcare facility immediately in the event of a suspected or confirmed case of COVID-19 to consult about next steps. Places of business shall report suspected or confirmed cases to NHCOC by calling (928) 871-7014.

APPROVING THE REOPENING OF THE LAKE POWELL NAVAJO TRIBAL PARK, MONUMENT VALLEY NAVAJO TRIBAL PARK, MONUMENT VALLEY WELCOME CENTER, LITTLE COLORADO RIVER NAVAJO TRIBAL PARK, FOUR CORNERS MONUMENT AND TSÉYI' DINÉ HERITAGE AREA AT ORANGE STATUS NOTWITHSTANDING PUBLIC HEALTH EMERGENCY ORDER NO. 2021-005

The Navajo Nation Council hereby approves the reopening of the Lake Powell Navajo Tribal Park, Monument Valley Navajo Tribal Park, Monument Valley Welcome Center, Little Colorado River Navajo Tribal Park, Four Corners Monument, Tséyi' Diné Heritage Area at the Orange Status notwithstanding Public Health Emergency Order 20-21-005.

SECTION FOUR. SUPPORTING AND APPROVING THE CONTINUED IMPLEMENTATION OF THE DIVISION OF ECONOMIC DEVELOPMENT'S BUSINESS REOPENING PLANS AT ORANGE STATUS FOR BUSINESSES OPERATING WITHIN THE LAKE POWELL NAVAJO TRIBAL PARK, MONUMENT VALLEY NAVAJO TRIBAL PARK, MONUMENT VALLEY WELCOME CENTER, LITTLE COLORADO RIVER NAVAJO TRIBAL PARK,

FOUR CORNERS MONUMENT, TSÉYI' DINÉ HERITAGE AREA NOTWITHSTANDING PUBLIC HEALTH EMERGENCY ORDER 2021-005

The Navajo Nation Council hereby supports and approves the continued implementation of the Division of Economic Development's Business Reopening Plans at Orange Status for businesses operating within the Lake Powell Navajo Tribal Park, Monument Valley Navajo Tribal Park, Monument Valley Welcome Center, Little Colorado River Navajo Tribal Park, Four Corners Monument, Tséyi' Diné Heritage Area notwithstanding Public Health Emergency Order 2021-005.

SECTION FIVE. EFFECTIVE DATE

This action of the Navajo Nation Council herein shall be effective pursuant to 2 N.N.C. § 221(B). Further, the "President's authority to sign into law or veto legislation shall be deemed waived if not exercised within ten calendar days after certification of the legislation by the Speaker or Speaker Pro Tem and the legislation shall be deemed enacted and become effective pursuant to 2 N.N.C. §221." 2 N.N.C. § 1005(C)(12).

SECTION SIX. SAVINGS CLAUSE

Should any provision of this action be determined invalid by the Navajo Nation Supreme Court, or the District Courts of the Navajo Nation without appeal to the Navajo Nation Supreme Court, those provisions not determined invalid shall remain the law of the Nation.

Public Health Emergency Order No. 2021-005

Public Health Emergency Order Declaring "Orange Status" for Businesses

- I. Paragraphs I IX from Public Health Emergency Order No. 2020-004 are incorporated herein, addressing the various Navajo Nation (Nation) authorities related to the current COVID-19 Public Health Emergency as well as escalating incidents and community spread of COVID-19 on the Nation.
- II. In response to COVID-19, the Navajo Nation has established the "Navajo Nation Reopening Plan," to declare the Nation's "status" according thereto, and to guide businesses in proper compliance with the plan. All provisions of this Order are to be interpreted to effectuate this intent. Failure to comply with any provision of this Order constitutes an imminent threat and menace to public health.
- III. The Navajo Nation is experiencing a gradual downward trajectory of new cases, with a slowed infection rate and no sustained rebound. The Nation remains vigilant as neighboring states are reducing restrictions rapidly and new COVID variants are present and being monitored in states surrounding the Navajo Nation. As coronavirus vaccines are being made available on the Navajo Nation, all preventative precautions should continue to be adhered to after receiving the vaccine.
- IV. The safest place continues to be at home. According to the Centers for Disease Control and Prevention, "COVID-19 cases and deaths have been reported in all 50 states, and the situation is constantly changing especially due to emerging variants (B.1.1.7 UK, B.1.351 South Africa, P.1 Brazil). Because travel increases your chances of getting infected and spreading COVID-19, staying home is the best way to protect yourself and others from getting sick."
- V. According to the Centers for Disease Control and Prevention, "Limiting face-to-face contact with others is the best way to reduce the spread of coronavirus disease 2019 (COVID-19)" and "the more closely you interact with others and the longer that interaction, the higher the risk of COVID-19 spread."
- VI. The Nation's roads remain closed to Visitors for the duration of the declared public health emergency, and Visitors are advised to refrain from traveling to the Navajo Nation. Tribal parks will not be accessible to Visitors and Tourists during this time. Visitors and Tourists will be informed when the Navajo Nation can safely welcome Visitors back to the Nation.

THEREFORE, NOTICE IS GIVEN that pursuant to the power and authority set forth in the NDOH enabling legislation (NNC Resolution No. CO-50-14) and in conjunction with the Navajo Nation Public Health State of Emergency Declaration (CEM Resolution No. 20-03-11):

- A. The Navajo Nation Reopening Plan is declared binding on all businesses on the Navajo Nation. Available at https://www.navajoreopening.navajo-nsn.gov/.
- B. Per the Plan's "reopening status schedule," the Navajo Health Command and Operations Center ("NHCOC"), having evaluated the current state of the Navajo Nation per the gating criteria and public health considerations provided in the Plan, declares the Nation to be in Orange status. All businesses shall be bound to the conditions and requirements of Orange status. The NHCOC will announce any future status changes by Public Health Emergency Order.
- C. Orange status is defined as: 25% of maximum occupancy allowed for most businesses. Restaurants and Dining facilities: drive-thru and curb-side permissible. Restaurants with permanent outdoor dining may provide outdoor dining at 25% of maximum capacity, as long as social distancing between tables is enforced; Restaurants without permanent outdoor dining are allowed up to 10 outdoor tables (max 4 persons per table), as long as social distancing between tables is enforced. Personal Care and Services: service by appointment only and allow time for cleaning between appointments. Marinas and parks: appointment only. Casinos and video poker: Navajo casinos are allowed to open to Navajo Nation residents and employees only. Not Allowed in Orange Phase: youth programs, museums, flea markets, roadside markets, gyms, recreation facilities, movie theaters.
- D. All businesses will be required to submit a COVID-19 Reopening Plan to the Navajo Nation Division of Economic Development before reopening in Orange Status. Reopening plans can be emailed to: navajoeconomy@navajo-nsn.gov

NOTICE IS FURTHER GIVEN that this Order shall not abrogate any disease-reporting requirements (consistent with HIPAA privacy standards).

NOTICE IS FURTHER GIVEN that this Order shall take effect Monday, March 15, 2021 at 5:00 A.M. MDT, and shall remain in effect until amended or rescinded by the Health Command Center.

ADDITIONAL ADVISORIES AND ORDERS WILL FOLLOW AS CONDITIONS WARRANT. SO ORDERED THIS 10th Day of March, 2021.



One of the biggest concerns lately in our area (Antelope Canyon, Lechee AZ) is the trespassers that visit the canyons. As it is getting warmer and the states are opening back up, we see more evidence of people visiting the canyons unauthorized. They leave behind trash, human waste and vandalism of the canyon walls. The tour operators and families living in the area try to employ staff to monitor for trespassers but it has become difficult due to the prolonged closure and no revenue for the past year. The nearby Parks and Recreation office also do not have the staff to monitor the Parks, so it is left to the families/tour operators to care for the canyons. As tour operators, our first and foremost duty is to protect the canyons. It is then our objective to provide safe and enjoyable tours to our visitors. But all the while, it is so that we can protect the canyons for what is exactly happening right now with these trespassers (damage and desecration of the canyons).

In support of this legislation, I feel this is a most important step to rebuild our economy and begin to heal as a people, as a community, and as a Nation. Our businesses that rely on the opening of these parks can start to rebuild. Families can return to employment closer to home. And in doing so, they can reunite (many families are displaced in order for one or more of the parents leaving the home to find employment in the cities). Our economy needs immediate attention as we continue to maintain our gains on this virus. That is why this legislation is important at this time.

The COVID-19 global pandemic has had a profound impact on Taadidiin Tours LLC and those who depended on the economic and socioeconomic support of the Navajo Tribal Park tourism industry. Taadidiin Tours LLC has been closed since March 13, 2020 due to the closing of the Navajo Tribal Parks. The financial strain on the company has been severe. The most heartbreaking ramifications of COVID-19 is hearing the struggles of our former employees.

Taadidiin Tours LLC is a woman owned and Navajo operated company. The company was started in 2017 with only 3 employees, two used suburbans and a pop-up canopy on the side of the road. By the start of 2020, the company had grown to 34 fulltime-permanent employees and had planned to hire an additional 20 temporary employees for the upcoming summer peak season. The majority of the temporary summer employees are typically Navajo high school and college students. All the employees have been laid off and remain that way until the Navajo Tribal Parks are reopened.

The company's cash flow was reversed on March 13, 2020 and continues to this day. The prepaid reservations for 2020 had to be cancelled and refunded. The bank fees, credit card fees, international currency fees, and reservation refund fees associated with refunding prepaid customers has been a substantial unforeseen expense. Many of the operating expenses in place at the start of the pandemic could not be put on hold. Taadidiin Tours LLC had acquired tour vehicles through loans to meet tourism demand. The sudden stop in revenue forced the below market sale of 8 company tour vehicles. The tour revenue may have stopped on March 13, 2020, but the costs of owning and operating did not.

Obligated Operation Costs After Closing

- Tour Vehicle Payments
- Vehicle Insurance on Financed Vehicles
- General Liability Insurance (Yearly Agreement)
- Company Phones and Plans
- Radio System (Service Agreement Contract)
- Portable Toilet Rentals

The Navajo economic benefits of the Navajo Tribal Parks extend beyond just tours.

- Navajo jewelry vendors setup and sell their products at our office location.
- We have several burrito and tamale ladies that sell breakfast and snacks to our employees every day.
- We use a Navajo septic tank company to service our portable toilets once a week.
- We provide college scholarships to employees and their dependent children.
- We sponsor youth sports teams, leagues and Navajo community events.

Much like our business, our former Navajo employees had financial obligations that unemployment insurance, government stimulus checks and other lower job salaries could not pay for. We have had many long and dejected conversations with employees concerning their financial struggles due to the closing of the Navajo Tribal Parks. We have created a short list of the impacts.

- Vehicle Repossession
- Rent Delinquency
- Unpaid Utility Bills
- Loss of Scholarships
- Divorce and Spousal Separation
- Credit Score Damage
- Increased Credit Card Debit
- College Students Working for Support Family and not Returning to School
- Liquidation of Personal Assets
- Furniture and Appliance Repossession
- Depression and Anxiety
- Off Reservation Relocation for Employment

Former employees feel it is safe to reopen and are eager to return to work for Taadidiin Tours LLC. We have also had a huge amount of new employment inquires. There are constant emails and phone calls from potential employees and customers on a possible reopening date.

Taadidiin Tours LLC management has spent a large amount of time and resources to develop a reopening plan to mitigate the risks of contacting and spreading COVID-19. We believe it is the most comprehensive and complete plan out of any sector or industry. The canyon tour our company provides is completely outdoors. Internally, we have discussed and researched COVID-19 in an outdoor environment and have determined the probability of spreading COVID-19 outdoors is extremely low.

Taadidiin Tours LLC's ownership and management strongly feel that we can reopen and operate the tours while protecting our employees and the public. Taadidiin Tours LLC has already purchased and installed engineering controls to mitigate COVID-19 risk. The new COVID-19 procedures and policies will be implemented on reopening and extensive employee training will be provided.

I am a vendor from Cameron, Arizona. I normally sell on HWY 64, going in the direction of the East Entrance to the Grand Canyon.

I am a single parent with 2 children. The father of my children has tried providing financially for our kids, however, during the NN closure he is only able to work off the reservation. He did find employment here in Cameron for a short time but \$11 an hour, part time shifts for two weeks equaled out to be \$160.00. Our generator for our kids' zoom classes takes up a good portion of the \$3.19 per gallon on gas. I buy ice for our ice chest. I have solar garden lights for lighting and a propane heater. With him working off the reservation helps for a short period of time before he starts drinking his money away. It's been very difficult to depend on someone who is not willing to stay sober to help his own kids. Prior to the pandemic, I made an income off whole selling and selling as a vendor. It was consistent and reliable. Now, I find myself borrowing money to get my kids to their hospital appointments. Please, work with us. Not having an income has been difficult during this pandemic. I understand the CDC guidelines, we practice it daily and more so when my children have their hospital appointments.

I am a resident of Cameron, Arizona. I've been selling jewelry all my life, I grew up at one of those stands. My family was able to pay for my education off the income from the selling sites on highway 64. It's been finally supporting most of the Cameron residents for many generations.

Reopening would financially help many of us move forward in this pandemic we are facing. I am not able to support myself or my daughter waiting for a stimulus check from the government. I am a single parent and make my living off selling my handmade Navajo Jewelry. Even with the help of a stimulus check, it easily went to 1 car payment and food for the week. With the closure of the stands I was forced to join NACA (Native American for Community Action) to be able to continue selling.

With everything going on I've adapted to the new changes to keep myself as well as our people safe. I've started an online approach to give my customers the opportunity to buy online if they have health conditions and are not able to wear a mask. I've order custom made signs that display

- -Mask Required
- -Please stay 6 ft apart
- -Please sanitize before touching jewelry

I no longer take any cash payments, I've resorted to using other forms of payment that do not require a physical exchange of money.

- -Google Pay
- -Apple Pay
- -Venmo
- -Paypal
- -Zelle
- -Facebook Pay
- -Cash App

If I am taking a credit card payment I use **Square** as a card processor. Square has a bluetooth reader available for customers like me. With the bluetooth reader I am able to take a payment with a tap. Then I wipe down the card reader with sanitizer wipes.

I disinfect my jewelry after all customer contact, before customers touch my jewelry I ask them to sanitize, afterwards I will sanitize the touched pieces.

While selling I wear gloves to avoid any direct contact with customers.

I have a 6 year old that I need to get home too everyday, nothing worries me more than not being well enough to care for her. Ensuring we are following the CDC guidelines is a high priority for myself as well as many of the vendors that are waiting for the reopening of highway 64. As a young single mother I am looking forward to the reopening of 64.

With herd immunity becoming a common goal and education on rising variants, we as vendors are aware to be cautiously optimistic. The awareness and enforcement on safety measures is ingrained to be second nature for our vendors because we return home to loved ones, we care about our neighbors, and we care for our Navajo Nation.

I hope you have confidence in us as we have maintained confidence in our leaders, trusting you have our wellbeing in mind. A great factor in our wellbeing is to be able to provide for our families. Winter will be upon us and with empty pockets, we are financially stressed. Bills are stacked and we are only lucky we are not disconnected from our utility connection because we reside on the Navajo Nation. We pay for firewood, live stock feed, water hauling, and most importantly feed, shelter, and clothe our children and some of us daughters & sons take care of our parents.

Stating the obvious, we do practice social distancing, 6ft apart, sanitation, PPE, and communicate heavily with signage. Many of us lost loved ones, many of us prayed for recoveries, many of us still fear COVID19, and that is more reasons to abide by the CDC guidelines. We need to earn an income to lessen the winter financial plight. I hope our leaders factor in we have been without an income for more than a year. Thank you for your ongoing advocacy to represent Diné lives.

To whom it may concern,

My name is Clarissa Chee, I am a 3rd generation resident of Tappen Wash in Cameron, Arizona. My family have relied on the selling site along highway 64 to support our family for many generations. I grew up watching my mother sell at these sites long before the development happened. Having been there full time to having the virus completely shut us down really had us in a tough spot financially.

At this time, I am going on over a year of no selling at my selling site on highway 64 milepost 277. This is my only source of income for my family of 5. We've gotten this far having to travel great distances to sell at other open CDC approved sites such as NACA (Native American for Community Action). These selling sites, a lot of supplies and equipment goes into having to set up there. We also have to pay a daily selling fee that can go up to \$65.00 per day.

To get ready for the slow reopening I've made a few changes to my business.

- Each morning before I go out to sell I check my temp, I record each day in regards to my health and how I'm feeling.
- To avoid taking any cash transactions, I accept Venmo, Paypal, and Zelle as other forms of payment. In regards to credit cards, I have a bluetooth card reader so when I accept cards there's no physical contact.
- I display signs that read "No Mask No Business", "Masks are Required to enter shop", " Where your Mask & Stay 6ft apart" If customers do have have a mask, I always carry 50 extras each day to give out. If they refuse to wear a mask I always highly encourage customers to shop online at my facebook store to continue to provide the customer service.
- In regards to my jewelry I encourage my customers to sanitize before handling the products. All touched jewelry is immediately cleaned with alcohol or sanitary wipes. Before customers touch my jewelry they will need to sanitize, as I always provide hand sanitizer pumps at each table.
- I only allow up to 4 people at my table to encourage social distancing. In my stand I plan to only allow up to 5 people inside at a time. Each customer will have to sanitize their hands and wear a mask before entering.
- At our pay station we have placed a custom plexiglass sneeze guard.

I've taken these extra steps to ensure I am keeping my loved ones at home safe. I have a family to go home to as well so for me to make sure they are safe as well as my customers I'm taking the extra precaution. I am also very open to additional training as well.

Thank you for taking the time to hear us out as vendors. I hope you take our concerns into deep consideration.

Public Health Emergency Order No. 2021-011

Public Health Emergency Order Continuing "Yellow Status" for Businesses

- I. Paragraphs I IX from Public Health Emergency Order No. 2020-004 are incorporated herein, addressing the various Navajo Nation (Nation) authorities related to the current COVID-19 Public Health Emergency as well as escalating incidents and community spread of COVID-19 on the Nation.
- II. In response to COVID-19, the Navajo Nation has established the "Navajo Nation Reopening Plan," to declare the Nation's "status" according thereto, and to guide businesses in proper compliance with the plan. All provisions of this Order are to be interpreted to effectuate this intent. Failure to comply with any provision of this Order constitutes an imminent threat and menace to public health.
- III. The Navajo Nation is experiencing a plateau of low cases, with a slowed infection rate and no sustained rebound. The Nation remains vigilant as neighboring states are reducing restrictions rapidly and new COVID variants are present and being monitored in states surrounding the Navajo Nation. As coronavirus vaccines are being made available on the Navajo Nation, all preventative precautions should continue to be adhered to after receiving the vaccine. The Navajo Nation recently documented cases of COVID-19 UK variant (B.1.1.7) and California variant (B.1.429) within the Navajo Nation. According to the CDC, these variants seem to spread more easily and quickly.
- IV. Pursuant to Navajo Nation Resolution No. CMA-16-20, the Nation's roads remain closed to Visitors for the duration of the declared public health emergency, and Visitors are advised to refrain from traveling to the Navajo Nation. Tribal parks will not be accessible to Visitors and Tourists during this time. Visitors and Tourists will be informed when the Navajo Nation can safely welcome Visitors back to the Nation.

THEREFORE, NOTICE IS GIVEN that pursuant to the power and authority set forth in the NDOH enabling legislation (NNC Resolution No. CO-50-14) and in conjunction with the Navajo Nation Public Health State of Emergency Declaration (CEM Resolution No. 20-03-11):

A. The Navajo Nation Reopening Plan is declared binding on all businesses on the Navajo Nation. Available at https://www.navajoreopening.navajo-nsn.gov/.

- B. Per the Plan's "reopening status schedule," the Navajo Health Command and Operations Center ("NHCOC"), having evaluated the current state of the Navajo Nation per the gating criteria and public health considerations provided in the Plan, declares the Nation to continue in **Yellow status**. All businesses shall be bound to the conditions and requirements of Yellow status. The NHCOC will announce any future status changes by Public Health Emergency Order.
- C. Yellow status is defined as: 50% of maximum occupancy allowed for most businesses. Restaurants and Dining facilities: drive-thru and curb-side permissible. Restaurants with permanent outdoor dining may provide outdoor dining at 50% of maximum occupancy, as long as social distancing between tables is enforced; Restaurants without permanent outdoor dining are allowed up to 10 outdoor tables (max 4 persons per table), as long as social distancing between tables is enforced; Personal Care and Services: service by appointment only and allow time for cleaning between appointments. Casinos and video poker: Navajo casinos are allowed to open at 50% of maximum occupancy to Navajo Nation residents, citizens and employees only (no visitors and tourists). Lodging and hotels including campgrounds and RV parks are allowed at 50% of maximum occupancy.
- D. Restaurants may provide indoor dining at 50% of maximum occupancy. Marinas and parks are allowed to open at 50% of maximum occupancy to Navajo Nation residents, citizens and employees only (no visitors and tourists). Tour businesses must follow the HCOC Reopening Guidelines for Tour Businesses. Museums and zoos are allowed to open at 50% of maximum occupancy.
- E. Flea markets and roadside markets are allowed in accordance with guidelines issued by HCOC, including:
 - 1. Temporary food stands are permitted to operate under the same provisions as temporary food service establishment under the Navajo Nation Food Service Sanitation Code/Regulations.
 - 2. Permit and food handler's card are required to be displayed during operation.
 - 3. If expired, any vendor must renew permit and food handler's card prior to operation.
 - 4. Management entities overseeing or managing the site where vending is occurring, shall be responsible for ensuring that these guidelines are followed. Management Entity: The owner of the permanent property where temporary vendors are conducting business. Includes individuals, businesses, and local governance units.
- F. Currently Not Allowed in the Yellow Phase: youth programs. The HCOC is evaluating reopening youth programs. Further guidance will be issued in the future to reopen.
- G. Not Allowed in Yellow Phase: gyms, recreation facilities, movie theaters.

H. All businesses are required to submit a COVID-19 Reopening Plan to the Navajo Nation Division of Economic Development before reopening in Yellow Status. Reopening plans can be emailed to: navajoeconomy@navajo-nsn.gov

NOTICE IS FURTHER GIVEN that this Order shall not abrogate any disease-reporting requirements (consistent with HIPAA privacy standards).

NOTICE IS FURTHER GIVEN that this Order shall take effect Monday, May 24, 2021 at 5:00 A.M. MDT, and shall remain in effect until amended or rescinded by the Health Command Center.
