Purpose of this Legislation:

to approve moratoriums on allocations from the UUFB, the Sihasin Fund, and Permanent Fund Income, until the Council determines otherwise.

16	BE IT ENACTED:

18	SECTION ONE. AUTHORITY	
19	A. The Budget & Finance Committee is a standing committee of the Navajo Nation Council	
20	that is authorized to review, and make recommendations concerning budgeting and	
21	management of all Navajo Nation funds. 2 N.N.C. §300(A), 2 N.N.C. §301(B)(2).	
22	B. The Naabik'íyáti' Committee is a standing committee of the Navajo Nation Council that is	
23	authorized to review all proposed legislations that require final action by the Navajo Nation	
24	Council. 2 N.N.C. §164(A)(9).	
25	C. The Navajo Nation Council is the governing body of the Navajo Nation. 2 N.N.C. §102(A).	
26	As such, the Council has the authority to review and approve all funding allocations from	
27	the Unreserved, Undesignated Fund Balance ("UUFB") of the Navajo Nation's General	
28	Fund, the Síhasin Fund, and Permanent Fund Income. See 12 N.N.C. §820(L); 12 N.N.C.	
29	§2505(A); 12 N.N.C. §905. The Council's authority inherently includes the power to freeze	
30	funding allocations from each of these Navajo Nation Funds.	

SECTION TWO. FINDINGS

- A. Over the past year, the Navajo Nation Council has approved many requests for funding allocations from the UUFB, the Síhasin Fund, and Permanent Fund Income. This has resulted in the significant depletion of these Funds.
- B. The Navajo Nation has received a substantial amount of federal funds from various sources, such as the American Rescue & Recovery Act/Fiscal Recovery Fund. Unlike the Navajo Nation Funds listed above, such federal funds have a deadline for the reversion of these funds, or for the payback of these funds to the federal government by the Navajo Nation.
- C. In order to spend all received federal funds by the reversion deadline, a significant number of Navajo Nation employees and administrative resources are required to carry out the funded projects and expenditures. As a general rule, all Navajo Nation personnel involved with such projects and expenditures should be focused on implementing and completing the federally-funded projects, rather than those funded with Navajo Nation funds that will not revert to the federal government.
- D. With such a plan, the Navajo Nation's limited available personnel will be concentrating on the numerous federally-funded projects that the Navajo Nation is currently managing, and the Navajo Nation will be more likely to meet the federal funds reversion deadlines. It is imperative that these deadlines be met, in order to avoid the loss of substantial federal funds.
- E. Because of the urgent need to focus on spending federal funds and completing federally-funded projects and expenditures before the applicable reversion dates, at this time the Navajo Nation should no longer approve funding requests from the UUFB, the Síhasin Fund, and Permanent Fund Income. Therefore, the Navajo Nation has determined that placing a temporary moratorium on additional funding allocations from the UUFB, the Síhasin Fund, and Permanent Fund Income, is in the best interest of the Navajo Nation.

SECTION THREE. APPROVAL OF MORATORIUMS

A. UUFB moratorium.

The Navajo Nation Council hereby establishes a moratorium on all future funding allocations from the Unreserved, Undesignated Fund Balance [of the Navajo Nation General Fund] described in 12 N.N.C. §820.

funds above the dollar amount originally approved by the Council for such plan.

- E. Notwithstanding, the moratoriums approved herein shall not apply to any UUFB, Síhasin Fund, or Permanent Fund Income appropriations approved by the Council in the Navajo Nation's annual Comprehensive Budget, as defined in 12 N.N.C. §810(H), for Fiscal Year 2023 or Fiscal Year 2024.
- F. The moratoriums established in this Action are not intended to prevent or delay the deposits of any Navajo Nation revenue, regardless of the source, into the UUFB (General Fund), the Síhasin Fund, or the Permanent Fund, if such deposits are mandated by any Navajo Nation laws, regulations, or policies. To this end, for the effective duration of the moratoriums established in this Action, no attempts shall be made to allocate any funds that are destined for the UUFB (General Fund), the Sihasin Fund, or the Permanent Fund.
- G. Each of the moratoriums established in this Action shall continue in full force and effect unless and until the Navajo Nation Council determines to lift one or more of them, either in whole or in part, via a Resolution adopted by a 2/3 vote of all sitting delegates and signed into law pursuant to 2 N.N.C. §221(B).

SECTION FOUR. EFFECTIVE DATE

This Action shall become effective in accordance with 2 N.N.C. §221(B).

SECTION FIVE. SAVING CLAUSE

If any provision of this Action is determined invalid by the Supreme Court of the Navajo Nation, or by a Navajo Nation District Court without appeal to the Navajo Nation Supreme Court, the remainder of this Action shall be the law of the Navajo Nation.
